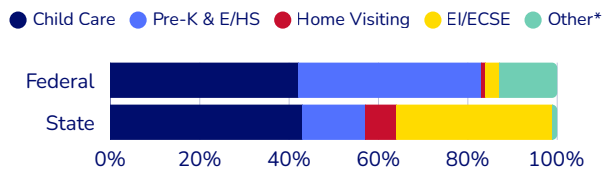


For every dollar spent on school-aged students in Ohio, \$0.12 was spent on infants and toddlers, and \$0.21 on preschool-aged children.

Ohio invested over **\$1.6 billion** in early care and education in 2023. Of these investments in birth to kindergarten-entry:

- **39%** supported infants and toddlers and **61%** supported children aged three to kindergarten-entry.
- **64%** came from federal sources, and **36%** came from state funds.

ECE Spending by Program Type

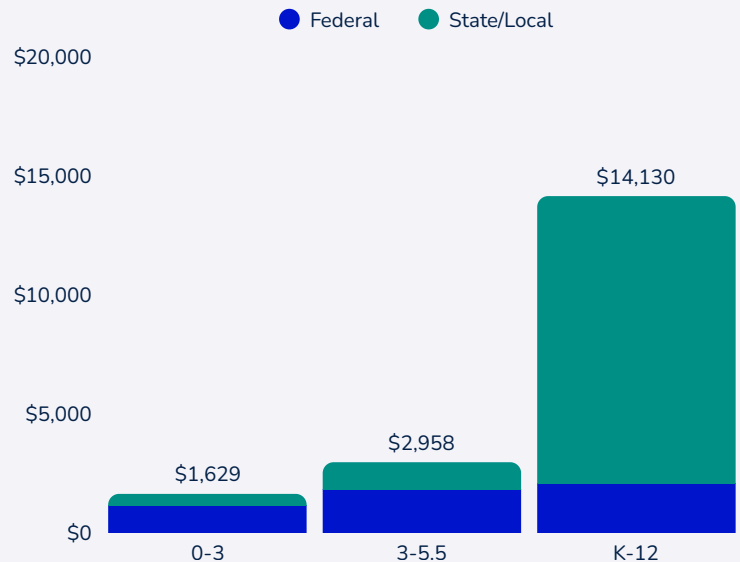


Between 2022 and 2023, Ohio increased state-specific spending on children from birth through kindergarten-entry by more than \$38 million.

In 2023, Ohio supported early care and education through dedicated programs such as Early Care and Education and the Help Me Grow Program. Continued investments will be reflected in future reports.

*Other federal funding includes the Child and Dependent Care Tax Credit (CDCTC), the Child and Adult Care Food Program (CACFP), and Child Care Access Means Parents in School (CCAMPIS).
