



For every dollar spent on K-12-aged students in Connecticut, **\$0.09 was spent on infants and toddlers, and \$0.15 on preschool-aged children.**

Connecticut invested over \$487 million in early care and education in 2022, yet only \$439 million of those dollars were reflected in national reports, leaving almost \$48 million – or 11% – of state and local spending uncaptured.

Of these investments in birth to K-entry:

- 41% supported infants and toddlers
  - 48% came from federal sources
  - 52% came from state funds
- 59% supported children age three to kindergarten entry

In 2022, Connecticut supported early care and education through dedicated programs such as Care4Kids, the School Readiness Program, and the Nurturing Families Network. Continued investments, such as Early Start CT, will be reflected in future reports.
