

For every dollar spent on K-12-aged students in Missouri, **\$0.14** was spent on infants and toddlers, and **\$0.27** on preschool-aged children.

Missouri invested almost \$893 million in early care and education in 2022, yet only \$607 million of those dollars were reflected in national reports, leaving over \$285 million – or 47% – of state and local spending uncaptured.

Of these investments in birth to K-entry:

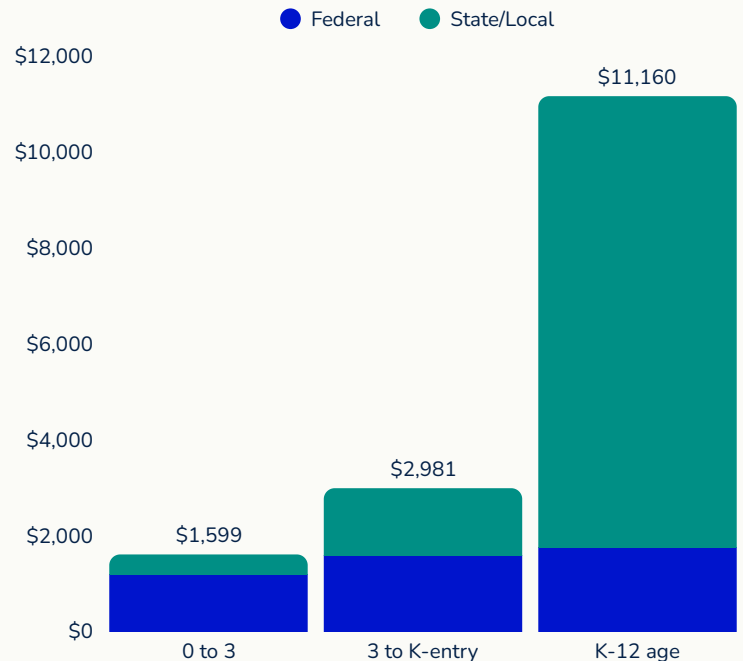
- 38% supported infants and toddlers
- 60% came from federal sources
- 62% supported children age three to kindergarten entry
- 40% came from state funds

In 2022, Missouri supported early care and education through dedicated programs such as the Child Care Subsidy Program, The Missouri Pre-K Foundation Formula, First Steps, and Early Childhood Special Education. Future reports will reflect continued investments, including the launch of the Missouri Quality Pre-K (MOQPK) program and increased funding for the Pre-K Foundation Formula.
